TENDER NOTICE

1. This office invites sealed quotations for the disposal of one condemned vehicle Toyota Corolla Altis No. DL-9CF-0036 (Model-2008) on as is where is basis. The condemned vehicle is being disposed as it is beyond economical repair in terms of the norms certified by the certifying authority DTC, Govt. of NCT of Delhi.
2. The vehicle can be inspected on any working day between 14:00 hrs. to 17:00 hrs. from 09.08.2021 to 02.09.2021 at Upbhokta Nyay Bhawan 'F' Block, GPO Complex, INA, New Delhi.
3. The quotation should be in a sealed cover superscribed as "Quotation for disposal of condemned vehicle" along with the bid security money of Rs. 30,000/- (Rupees thirty thousand only) in the form of payorder/Demand draft payable to Registrar, NCDRC drawn on any scheduled Bank payable at New Delhi. The bidder must also enclose a copy of his/her Aadhar card or any authentic identity proof with the tender. The sealed cover should be addressed to Registrar, NCDRC and must reach the undersigned on or before 02.09.2021 (17.00 hrs.). The quotations may be submitted to Registrar, NCDRC by hand.
4. The quotations received after the stipulated date/time or received without the earnest money of the identity proof shall be rejected.
5. The condemned vehicle will be sold to the highest bidder. However, the Competent Authority reserves the right to reject any or all quotations without assigning any reason thereof.
6. The successful bidder will have to make full payment by 08.09.2021 (17:00hrs) and only then he would be allowed to remove the vehicle from the premises. The successful bidder has to lift the vehicle completely at his own cost within two days from the date of deposit of full payment, failing which the bid security money shall be forfeited and pecuniary loss, if any, shall be recovered from him.
7. The bid security money of the unsuccessful bidders shall be returned after the process is over.
8. The sealed quotations will be opened on 06.09.2021 at 15:00 hrs at the office of National Consumer Disputes Redressal Commission 'Upbhokta Nyay Bhawan' 'F' Block GPO Complex INA, New Delhi. Interested parties may participate in person or their representative at the time of opening of bids.
